To create a digital travel document visit <a href="http://www.guvendekalkkct.com">www.guvendekalkkct.com</a> and keep the completed form with printout with you when you enter the country.										
Country colour classification will be updated weekly by TRNC Health Committee. The country risk levels (colours) specified in the table will be applied to passengers upon their country of arrival.										
Entry from <b>Land Check Points</b> , from Republic of Cyprus are currently possible for Green Card holders with EU passport holders and those arriving from Visa Free countries.										
PCR / LAMP / ANTIGEN Tests can be applied at all entrance gates.										
Children under the age of 18 will be able to enter the country with their <b>vaccinated</b> parents in accordance with the above PCR test rules (which will apply on children over 6 years old)										
Acceptable Vaccines : 2 Doses of : SINOVA BIONTECH; SINOPHARM; VAXZEVRIA (AstraZeneca/Oxford); SPUNIK V; MODERNA; SPUTNIK V; NOVAVAX										
1 Dose of : VACCINE JANSSEN/Johnson and Johnson
